#### MEASURING and HEIGHT CARD INFORMATION

All agility dogs are required to have an Official Jump Height Card and exhibitors must be able to present it prior to running their dog(s) in any class or at any time during the trial upon request. - If the volleyball area is used as a crating, grooming, preparation, or resting area for the animals, all areas used for such purposes will be covered with sufficient floor covering materials to insure no damage occurs to the sport court floor.
- There are outside areas that may be used to exercise and allow your dogs to relieve themselves. All fecal matter will be bagged and disposed of promptly and properly in the appropriate receptacles provided by Arena Sports.
- Everyone, including but not limited to, volunteers, show committee, handlers, attendees and participants will take appropriate steps to insure that their animals do not relieve themselves inside the facility, especially on the turf or the sport court floor. In the event an accident occurs, all fecal materials and urine will be removed, and the area will be thoroughly cleaned and sanitized.
- No outside food or beverage is allowed.
- No dogs are permitted on the 2<sup>nd</sup> level, including the pub. café and spectator area. Dogs are permitted only on the 1<sup>st</sup>/ground floor. No dogs are permitted in the restrooms.
